

Application process & scholarships

For non-EU applicants only



How to apply?

The first step is to submit your application documents. These consist of the completed application form, your curriculum vitae, proof of English, letter of motivation, copy of international passport, copy of your last school report and, if applicable, copy of first academic degree and proof of work experience.

Bachelor admission requirements

The higher education entrance qualification is a prerequisite for a bachelor's degree course at CBS. Foreign qualifications are recognised if they are equivalent to the German university entrance qualification. You can apply all year round with your last school report.

Students having secondary school qualifications which are not equivalent to the German secondary school qualification can also join our one year Prep4University foundation programme in order to obtain a university qualification to study at CBS.

Master & MBA admission requirements

The admission requirements for our CBS Master programmes are a first academic qualification with a minimum of 180 ECTS-Credits of a recognised university with a final grade of at least “good”. For Master programmes, the degree should be business-related. For MBA programmes, the degree does not have to be business-related, but requires at least one year of work experience.

CBS Scholarships

Non-EU students can receive one-time scholarship of 3.000 EUR in the Bachelor, Master and MBA full time programmes, if they have a good motivation and academic performance in their previous studies. Country specific promotions are also available for non-EU students.

EU students can receive merit based 25% scholarship if they are selected. Please check cbs.de/en for how to apply for EU students scholarship.

GERMAN LANGUAGE PROGRAMMES

You speak German or you are in the process of learning it? Of course, we also offer a large part of our study programs in German. To study in German you need a language certificate for admission. The requirement for a Bachelor's degree

is a B2 language level and for a Master's degree a C1 language level. You can obtain the necessary certificate at the Goethe Institute, for example.

DUAL STUDY PROGRAMMES

You are not currently working in a profession or job that you would like to continue, but still want to work while studying for your degree? Then the dual variant is exciting for you. This is because we specifically bring a cooperating company on board, where you can continuously gain work experience during your studies. The courses are then structured in Modular block phases. For you to be able to win over your desired company, specialists as well as a personal study support team from the CBS will be at your side and will accompany

you with advice and action until you are successful in finding a practice partner. And best of all: If everything fits, you have already found your employer for the time after your degree.
